This Application and Questionnaire will be kept confidential and will be examined only by members of the Judicial Selection Commission and the Governor, unless you are nominated by the Governor, at which time it will be made public.

The Governor's Executive Order creating the Judicial Selection Commission provides that "The names of persons considered by the Commission shall remain confidential except to the extent necessary for the Commission to carry out its responsibility to evaluate candidates." The Judicial Selection Commission will email you a letter acknowledging receipt of your Application and Questionnaire, and may also contact you to appear for an interview. The Judicial Selection Commission will not otherwise contact you regarding the status of your application until after the Governor announces her nominee.

With respect to the last 10 years, list all bar associations, judicial associations, and professional societies of which you are, or have been, a member and give titles and dates of any offices which you have held in such groups. List chairpersonships and memberships of any committees in bar or judicial associations or professional societies which you believe to be of particular significance. Please also list any honors, prizes or awards you have received.

CONDUCT
